

# MURPHY'S PARK SECTION 2

Situated in the State of Ohio, County of Delaware, Village of Powell and in Farm Lots 28 and 29, Quarter Township 4, Township 3, Range 19, United States Military Lands, containing 13.542 acres of land, more or less, (6.386 acres being in Farm Lot 28 and 7.156 acres being in Farm Lot 29) said 13.542 acres being all of that tract of land conveyed to **ROCKFORD HOMES, INC.**, by deed of record in Official Record 000, Page 000, Recorder's Office, Delaware County, Ohio.

The undersigned, **ROCKFORD HOMES, INC.**, an Ohio corporation, by **DONALD R. WICK**, Vice President, owner of the land platted herein, duly authorized in the premises, does hereby certify that this plat correctly represents its "MURPHY'S PARK SECTION 2", a subdivision containing Lots numbered 0000 to 0000, both inclusive, does hereby accept this plat of same and dedicates to public use, as such, all or parts of Safreed Way, Shyanne Court, Shyanne Drive and Tree Haven Avenue North shown hereon and not heretofore dedicated.

Easements are reserved in, over and under areas designated on this plat as "Easement" or "Drainage Easement" for the construction, operation and maintenance of all public and quasi public utilities above and beneath the surface of the ground and, where necessary, for the construction, operation and maintenance of service connections to all adjacent lots and lands and for storm water drainage. Within those areas designated "Drainage Easement" on this plat, an additional easement is hereby reserved for the purpose of constructing, operating and maintaining major storm water drainage swales and or other storm water drainage facilities. No above grade structures, dams or other obstructions to the flow of storm water runoff are permitted within Drainage Easement areas as delineated on this plat. Easement areas shown hereon outside of the platted area are within lands owned by the undersigned and easements are hereby reserved therein for the uses and purposes expressed herein.

A non-exclusive easement is hereby granted unto Del-Co Water Company, Inc., its successors and assigns, for the location of water lines, valves and appurtenances within the rights-of-way dedicated hereon, and within areas alongside said rights-of-way designated hereon as "Easement" or "Drainage Easement". Also granted is the right of Del-Co Water Co., Inc., to install, service and maintain water meter crocks and appurtenances in said easement areas alongside said rights-of-way.

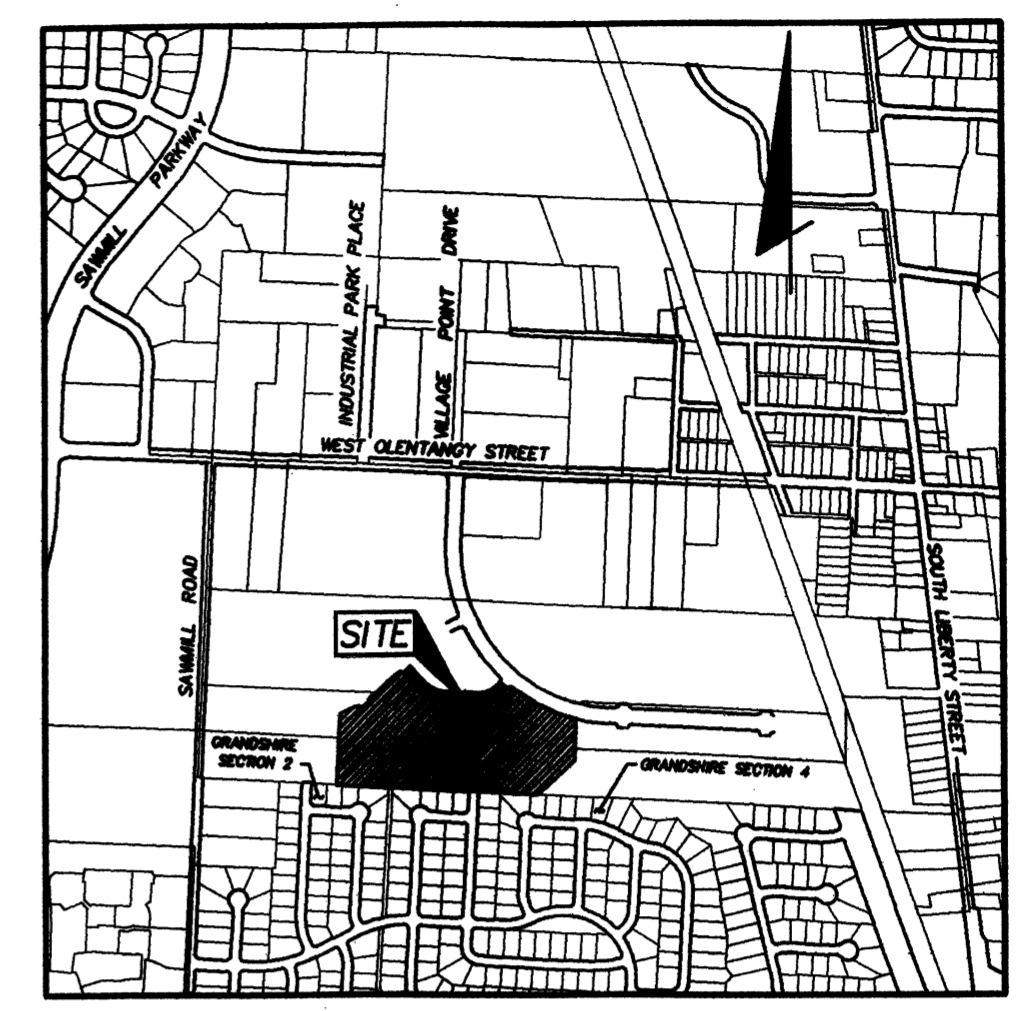

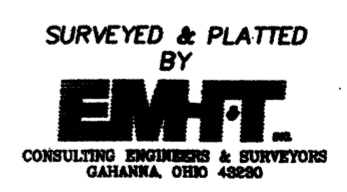
**SURVEY DATA:**

**PERMANENT MARKERS**, where indicated, unless otherwise noted, are to be set and are iron pipes, one inch inside diameter, thirty inches long..
