Ordinance No. 2001-64 Passed October 16 YEAR 2001

AN ORDINANCE MODIFYING APPROPRIATIONS FOR THE CALENDAR YEAR 2001.

WHEREAS, Council has determined that it is necessary to modify appropriations for the calendar year 2001 in accordance with the attached exhibit. This exhibit becomes a part of this ordinance and shall be marked "Exhibit A."

WHEREAS, additional funds have been received for commercial building permits above the amount originally estimated, and

WHEREAS, three percent (3%) of said commercial building permit fees are held in a separate trust fund for monthly payment to the State Board of Building Standards, and

WHEREAS, additional funds are needed to pay for improvements to the Village Green Municipal Building, and

WHEREAS, additional funds are needed to provide for engineering and surveying services for roadside ditch repair work.

NOW THEREFORE BE IT ORDAINED BY THE MUNICIPALITY OF POWELL, DELAWARE COUNTY, OHIO AS FOLLOWS:

Section 1: That the Finance Director is hereby directed to certify an additional \$2,000 in revenue for the Board of Building Standards to the Delaware County Auditor.

Section 2: That Council hereby modifies its appropriations for the calendar year 2001 by increasing certain accounts and decreasing others due to adjustments that need to be made to the funds.

Section 3: That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of the Council and that all deliberations of the Council and any of the decision making bodies of the Municipality of Powell which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the Municipality of Powell, Delaware County, Ohio.

Section 4: That this Ordinance shall take place at the earliest period allowed by law.
