YEAR

AN ORDINANCE APPROVING AND ADOPTING THE 2002 REPLACEMENT PAGES TO THE CODIFIED ORDINANCES OF THE MUNICIPALITY OF POWELL.

WHEREAS, The Council of the Municipality of Powell has passed various ordinances of a general and permanent nature which should be included in the Codified Ordinances; and

WHEREAS, certain traffic and misdemeanor provisions should be revised to comply with current State law; and

WHEREAS, the codification of such ordinances, together with the new matter to be adopted, the matters to be amended and those to be repealed are before the Council.

NOW THEREFORE BE IT ORDAINED BY THE MUNICIPALITY OF POWELL, DELAWARE COUNTY, OHIO AS FOLLOWS:

Section 1: That the ordinances of the Municipality of Powell, Ohio, of a general and permanent nature, as revised, recodified, rearranged and consolidated into component codes, titles, chapters and sections within the 2002 Replacement Pages to the Codified Ordinances are hereby approved and adopted.

Section 2: That the following sections and chapters are hereby added, amended or repealed as respectively indicated in order to comply with current State law:

Section 3: That pursuant to Ohio R.C. 731.25 and Section 5.08 of the Charter, the Clerk of Council shall post copies of the 2002 Replacement Pages along with a copy of this Ordinance in three public places for a period of not less than fifteen days after their adoption.

Section 4: That it is hereby found and determined that all formal actions of this Council concerning and relating to passage of this Ordinance were adopted in an open meeting of the Council and that all deliberations of this Council and any of its committees which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the Municipality of Powell, Delaware County, Ohio.

Section 5: That this Ordinance shall take effect at the earliest period allowed by law.


