

ORDINANCE 2002-59

PASSED November 19, 2002

AN ORDINANCE MODIFYING APPROPRIATIONS FOR THE CALENDAR YEAR 2002 AND DECLARING AN EMERGENCY.

WHEREAS, Council has determined that it is necessary to modify appropriations for the calendar year 2002 to establish a Special Revenue Fund in accordance with the attached exhibit. This exhibit becomes a part of this ordinance and shall be marked "Exhibit A."

WHEREAS, The City of Powell has received a grant from the Office of Criminal Justice in the amount of \$107,677 for the purchase and installation of computer equipment in cruisers.

WHEREAS, it has been determined that an emergency exists in order to take advantage of and qualify for 2002 Grant Funds.

NOW THEREFORE BE IT ORDAINED BY THE MUNICIPALITY OF POWELL, DELAWARE COUNTY, OHIO AS FOLLOWS:

Section 1: That there be established a Special Revenue Fund known as the CJIS Consortium Project Grant Fund

Section 2: That the Finance Director is hereby directed to certify to the Delaware County Auditor an additional \$107,677 in revenue for the CJIS Consortium Project Grant Fund.

Section 3: Council hereby modifies its appropriations for the calendar year 2002 by increasing certain accounts and decreasing others due to adjustments that need to be made to the funds.

Section 4: That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of the Council and that all deliberations of the Council and any of the decision making bodies of the Municipality of Powell which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the Municipality of Powell, Delaware County, Ohio.

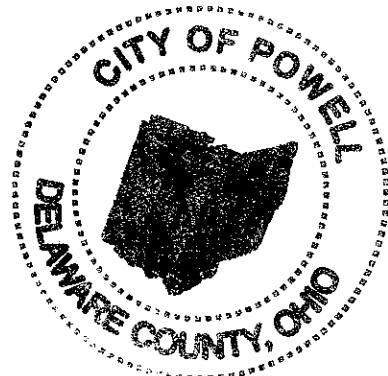
Section 5: That this Ordinance shall take effect at the earliest period allowed by law.
