

ORDINANCE 2003-15  
PASSED APRIL 8, 2003

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH EDSALL & ASSOCIATES LLC FOR CONSULTING SERVICES FOR THE PREPARATION OF DESIGN DEVELOPMENT, AND CONSTRUCTION DOCUMENTS AS WELL AS CONTRACT ADMINISTRATION, FIELD SELECTION AND CONSTRUCTION OBSERVATION SERVICES FOR THE CITY OF POWELL PARK MASTER PLANS AND DECLARING AN EMERGENCY.

**WHEREAS,** Edsall and Associates has prepared Master Plans for Arbor Ridge, Beechwood, Library, Meadow View, Memorial, Murphy's, Black Oak, Powell Place, and Village Green Parks.

**WHEREAS,** such master plans have been approved and adopted by the City Council on February 12, 2003.

**WHEREAS,** Council has determined that it is desirable to enter into contract with Edsall & Associates LLC for consulting services related to park development.

**WHEREAS,** Council hereby determines an emergency exists in the desire to begin implementation of the parks master plans in 2003.

**NOW THEREFORE BE IT ORDAINED BY THE MUNICIPALITY OF POWELL, DELAWARE COUNTY, OHIO AS FOLLOWS:**

Section 1: That the City Manager is hereby authorized to enter into a contract with Edsall & Associates LLC on behalf of the Municipality for the purpose of providing park consulting services pursuant to a contract as attached hereto and incorporated herein by reference.


Section 2: That the City Manager is hereby authorized to pay Edsall & Associates LLC the sum not to exceed *Six Hundred Ninety Two Thousand One Hundred Seven Dollars and fifty cents (\$692,107.50)* for cost of services rendered pursuant to the terms of the executed contract plus 5% contingency.


Section 3: That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of the Council and that all deliberations of the Council and any of the decision making bodies of the Municipality of Powell which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the Municipality of Powell, Delaware County, Ohio.

Section 4: That this Ordinance shall take effect immediately upon its adoption.
