1331.01 LICENSE REGISTRATION REQUIRED.

Any person or corporation intending to do work within the ~~Village City~~ of Powell for which a permit is required by this Building Code shall be ~~licensed by~~ registered with the Building Commissioner. The ~~license or licenses~~ registration shall cover work being done by that person or corporation. The person or corporation that has been ~~licensed-registered~~ shall be responsible for all work covered by the license registration meeting the Building Code. All ~~licenses~~ registrations issued to corporations shall list a member, employee or officer of that corporation who is the responsible representative of that registrant for all work in the ~~Village City~~. It shall be the responsibility of the licensee registrant to notify the ~~Village City~~ any time the responsible representative is changed for any reason. (Ord. 87-26. Passed 10-20-87.)

1331.02 REQUIRED LICENSES, REGISTRATIONS.

The following ~~licenses~~ registrations are required:

- (a) Building License Registration and a Remodeler's License Registration may be issued to the owner or the general contractor. This license registration may include some or all of the work being performed on the building or structure. It shall be the responsibility of the licensee registrant to insure that qualified ~~workmen~~ workers perform the various items of work in accordance with the Building Code in a good workmanlike manner.
- (b) All Electrical, Plumbing, Heating and Air Conditioning License Registration shall be issued to a person or corporation performing the work, ~~which holds a valid license in the City of Columbus, or other Central Ohio municipality which has a certified building department, when such work is not covered by the building~~

license upon submittal of application registration fee, proof of insurance, and/or evidence of Ohio license.

- (c) Demolition LicenseRegistration shall be required for any person or corporation performing demolition within the VillageCity. The licenseeregistrant shall be the Owner of the structure or building being demolished or a contractor licensed as a demolition contractor in the City of Columbus or other Central Ohio municipalities having certified building departments registered with Powell.
- (d) Moving LicenseRegistration shall be required for any person or corporation moving a structure or building within the City which requires a permit. The licenseeregistrant may be the Owner of the structure or building or a contractor with at least five years experience in moving of structures or buildings in the manner proposed.

1331.03 LICENSEREGISTRATION-RENEWAL.

Each licenseeregistration is for one year. The annual renewal of a licenseeregistration is required for a person or corporation to continue to work within the VillageCity.

1331.04 LICENSEREGISTRATION NONRENEWAL, REVOCATION.

A licenseeregistration may be ~~nonrenewal~~ nonrenewable upon its expiration or revoked at any time for the following reasons:

- (a) Failure to request renewal.
- (b) Failure to adhere to the requirements of the Building Code.
- (c) Failure to follow the lawful orders and instructions of the Building Commissioner or his authorized representative.
- (d) Have a building permit refused or revoked.
- (e) Failure to correct deficiencies, or unauthorized or unaccepted work.
- (f) Failure to obtain the required permits.
- (g) Having outstanding violations of the Building Code or outstanding violations by the Building Commissioner.
- (h) Continuing work after receipt of a stop work order.
