

ORDINANCE 2005-01
Passed January 4, 2005

AN ORDINANCE MODIFYING APPROPRIATIONS FOR THE CALENDAR YEAR 2005 AND
DECLARING AN EMERGENCY.

WHEREAS, Council has determined that it is necessary to modify appropriations for the calendar year 2005 to establish a Special Revenue Fund in accordance with the attached exhibit. This exhibit becomes a part of this ordinance and shall be marked "Exhibit A."

WHEREAS, The City of Powell has received a grant from the Ohio Tobacco Use Prevention and Control Foundation in the amount of \$8,768 for the cost to print and distribute post cards and mailers to residents to continue marketing efforts of the City's Clean Indoor Air Ordinance

WHEREAS, it has been determined that an emergency exists in order to take advantage of and qualify for Mini-Grant Funds which require that the funds be expended prior to April 30, 2005.

NOW THEREFORE BE IT ORDAINED BY THE MUNICIPALITY OF POWELL, DELAWARE COUNTY,
OHIO AS FOLLOWS:

Section 1: That there be established a Special Revenue Fund known as the Tobacco Use Prevention Grant Fund (Fund 262).

Section 2: That the Finance Director is hereby directed to certify to the Delaware County Auditor an additional \$8,768 in revenue for the Tobacco Use Prevention Grant Fund.

Section 3: Council hereby modifies its appropriations for the calendar year 2005 by increasing certain accounts and decreasing others due to adjustments that need to be made to the funds.

Section 4: That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of the Council and that all deliberations of the Council and any of the decision making bodies of the Municipality of Powell which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the Municipality of Powell, Delaware County, Ohio.

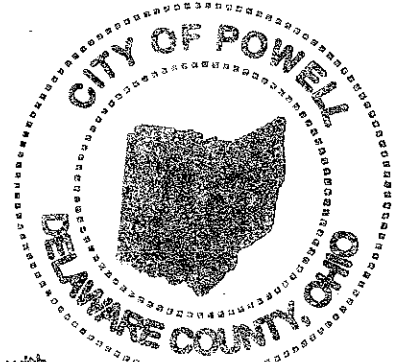
Section 5: That this Ordinance shall take effect at the earliest period allowed by law.
