**ORDINANCE 2006-14**

Passed January 21, 2006

**AN ORDINANCE MODIFYING APPROPRIATIONS FOR THE CALENDAR YEAR 2006 AND DECLARING AN EMERGENCY.**

**WHEREAS,** Council has determined that it is necessary to modify appropriations for the calendar year 2006 in accordance with the information contained herein.

**WHEREAS,** it is hereby determined that an emergency exists to allow the purchase and use of the Police Department forensic equipment funded through the Grant.

**NOW THEREFORE BE IT ORDAINED BY THE MUNICIPALITY OF POWELL, DELAWARE COUNTY, OHIO AS FOLLOWS:**

**Section 1:** That Council hereby modifies its appropriations for the calendar year 2006 by increasing certain accounts and decreasing others due to adjustments that need to be made to the funds. Council hereby determines an emergency exists in order to make the following adjustments:

Appropriate from the unappropriated fund balance:

1. Engineering Inspection Fund, in the amount of \$81,329.59.
2. Justice Assistance Grant Fund, Capital Outlay, in the amount of \$7,849.00.

Transfer:

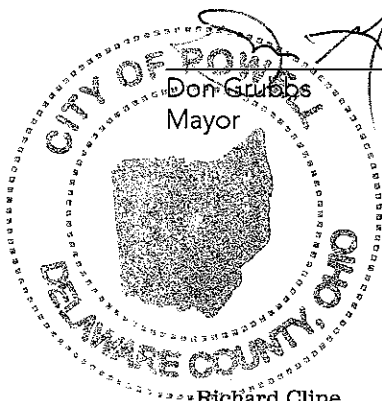
1. From the General Fund, Police Department, Operating Expenditures to the Justice Assistance Grant Fund, Police Department, Capital Outlay, in the amount of \$899.00.

**Section 2:** It is hereby found and determined that all formal actions of this Council concerning and relating to passage of this Ordinance were adopted in an open meeting of the Council and that all deliberations of this Council and any of its committees which resulted in such formal actions were in meetings so open to the public in compliance with all legal requirements of the Municipality of Powell, Delaware County, Ohio.

**Section 3:** That Council declares this to be an emergency measure necessary for the immediate preservation of public safety and welfare of the community. Wherefore, this Ordinance shall take effect and be in force from and after its passage and approval by the Mayor.
