RESOLUTION 2006-02

A RESOLUTION RECOGNIZING DAN WIENCEK'S TENURE AS MAYOR OF THE CITY OF POWELL 2004-2005.

WHEREAS, Dan Wiencek was elected by his fellow Council Members to serve as the Mayor of Powell from January 1, 2004 to December 31, 2005, and

WHEREAS, Dan Wiencek diligently met his responsibilities as Mayor with professional commitment, personal integrity, and sincere concern for the community and its residents, and

WHEREAS, as Mayor, Dan Wiencek pioneered passage of one of the first Clean Indoor Air Ordinances in the State of Ohio, making the City of Powell a healthier place to live, eat, and play, and

WHEREAS, during his tenure as Mayor, Dan Wiencek initiated a Downtown Revitalization Study to help determine how to strengthen and invigorate historic downtown Powell, bringing about the creation of a Downtown Committee to sustain the recommendations of the study, and

WHEREAS, Dan Wiencek was an advocate for the land swap with Liberty Township which resulted in providing City of Powell and Liberty Township residents with 25 acres of additional park land, and

WHEREAS, the City of Powell, Council, Staff and the entire community wish to recognize Dan Wiencek's extensive efforts on their behalf and to express their appreciation.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPALITY OF POWELL, DELAWARE COUNTY, OHIO AS FOLLOWS:

Section 1: That on behalf of all, our thanks are extended to Dan Wiencek, while knowing that he will continue to serve the public as Councilman with the same integrity, dedication, and loyalty which he demonstrated during his tenure as Mayor.

Section 2: That it is hereby found and determined that all formal actions of this Council concerning and relating to passage of this Resolution were adopted in an open meeting of the Council and that all deliberations of this Council and any of the decision making bodies of the Municipality of Powell which resulted in such formal actions were in meetings so open to the public in compliance with all legal requirements of the Municipality of Powell, Delaware County, Ohio.

Section 3: That this Resolution shall take effect immediately upon its adoption.


