**RESOLUTION 2006-36**

**A RESOLUTION AMENDING AND RENUMBERING RESOLUTION NUMBER 2006-32 ENTITLED "A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR."**

**WHEREAS,** Council adopted Resolution Number 2006-32 on September 19, 2006 to conditionally accept the public improvements in Golf Village Section VI, Phase B, Part III and,

**WHEREAS,** on October 3, 2006, Council adopted a Resolution numbered as 2006-32 accepting the amounts and rates as determined by the Budget Commission and authorizing the necessary tax levies and certifying them to the County Auditor, a copy of such Resolution adopted on October 3, 2006 is attached hereto and incorporated herein by reference and,

**WHEREAS,** the Resolution adopted on October 3, 2006 was incorrectly numbered 2006-32 through administrative error.

**NOW THEREFORE BE IT RESOLVED BY THE CITY OF POWELL, DELAWARE COUNTY, OHIO AS FOLLOWS:**


**Section 1:** That Resolution 2006-32 adopted on October 3, 2006 entitled "A Resolution Accepting The Amounts And Rates As Determined By The Budget Commission And Authorizing the Necessary Tax Levies And Certifying Them To The County Auditor" a complete copy of the same being attached hereto and incorporated herein by reference is amended and renumbered to Resolution Number 2006-37. Otherwise, all of the terms and provisions of the Resolution adopted on October 3, 2006 shall remain in full force and effect.



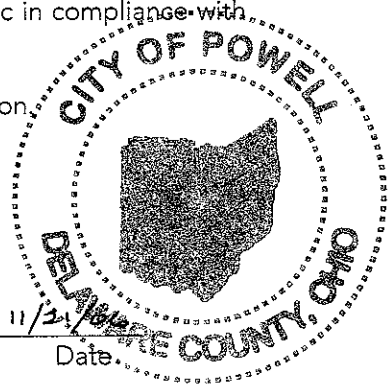

**Section 4:** This Resolution shall take effect immediately upon its adoption.


