**RESOLUTION 2006-37**

Adopted October 3, 2006

**A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR.**

**WHEREAS,** in accordance with the provisions of law, estimated revenues have been filed with the County Auditor for the next succeeding fiscal year commencing January 1<sup>st</sup>, 2007; and

**WHEREAS,** The Budget Commission of Delaware County, Ohio, has certified its action thereon to this Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council and what part thereof is without, and what part within the ten mill tax limitation.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPALITY OF POWELL, DELAWARE COUNTY, OHIO AS FOLLOWS:**

**Section 1:** That the amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted; and


**Section 2:** That there be and is hereby levied on the tax duplicate of said City the rate of each tax necessary to be levied within and without the ten mill limitation as is identified on "Schedule A" which is attached hereto and incorporated herein by reference.

**Section 3:** That it is hereby found and determined that all formal actions of this Council concerning and relating to passage of this Resolution were adopted in an open meeting of the Council and that all deliberations of this Council and any of the decision making bodies of the Municipality of Powell which resulted in such formal actions were in meetings so open to the public in compliance with all legal requirements of the Municipality of Powell, Delaware County, Ohio.

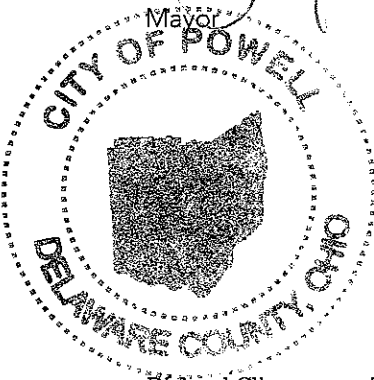
**Section 4:** That this Resolution shall take effect immediately upon its adoption.
