PERMIT REQUIREMENTS:

1. Completed application for Residential Zoning Certificate.
2. \$25.00 Non-Refundable Fee, Payable to the City of Powell
3. Site Plan – 2 Copies
 - Show dimensions of fence as well as dimensions of house to property line in a scaled drawing.
 - Give clear indication of location of the fence.
4. Design Plan – 2 Copies
 - Type of fence (i.e. split rail, picket, good-neighbor, etc.)
 - Materials (i.e. wood/cedar, stone, masonry, metal, etc.)
 - Color
5. Elevation/Section Plans – 2 Copies
 - Height – Note: Maximum height is five (5) feet.
 - Cross Sections
 - Method of Fastening
6. Developer/Homeowner Association Approval (if applicable)
