In addition to the full biographies of the proposed team attached hereto, below please find a summary of relevant experience as Powell Law Director and summary of experience with other municipal issues.

## Summary of Relevant Experience as Powell Law Director

It has been our honor and privilege to serve as the Law Director for the City of Powell for the past six years. Among the accomplishments and successful projects of the Powell team, of which we are a part, we count the following:

- Representation of City of Powell in mandamus proceedings before Ohio Supreme Court with regard to initiative petition to place a potentially unconstitutional charter amendment on the ballot (State ex rel. - Ongoing advice regarding proper interpretation and implementation of the Cooperative Economic Development Agreement between the City of Powell and Liberty Township, including advice regarding propriety of initiative petition.
- Implementation of the City's Tax Increment Financing District, including advising staff, correspondence with the Ohio Department of Taxation and coordination with the Delaware County Auditor's office.
- Assistance in conceptualization of potential incentive programs for attraction of new employers to the City of Powell and retention and/or expansion of existing commercial developments,

including formation of a Community Improvement Corporation and associated income tax offset incentives, as well as consideration of a commercial tax increment financing district.

  annexations, coordination with landowner's attorney regarding Urban Active Annexation,
